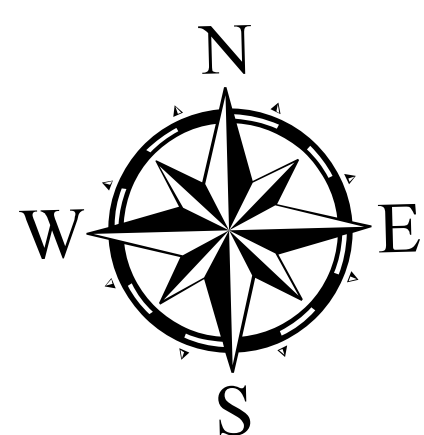


DEUEL COUNTY OWNERSHIP MAP
