Deuel County Commissioner Meeting June 18, 2024

The Deuel County Commissioners met on the above date with the following present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jon Stellar, County Treasurer Alicia Adams, County Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Deputy Sean Holloway, Deputy Jim McCormick, Roads Superintendent Kelly Kopetsky, Highway Superintendent Tony Krajewski, Kristian Fusilier, Jane Starostka, Chris Jones, Jim Reichman and Clerk Tammy Sherman. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, aye, Klingman, aye, Timm, aye, A motion by Commissioner Timm, seconded by Commissioner Klingman to approve the June 4th, 2024, meeting minutes. Public comment. Jane Starostka expressed concern about the dam on Wheatland Rd. and asked if warning signing could be put up warning drivers of the condition of the dam. She asked if there were any new grant funds available for repairing Wheatland Road. The Roads Dept. will get warning signs put in place for the dam on Wheatland Rd. The Roads Dept. is continually looking for funding for the repair work needed on Wheatland Rd. Unfortunately, no new funds have become available. Starostka asked for clarification on 4-H group shooting at the rifle range. The rifle range is closed to the public. The 4-H shooting club is allowed to practice at the rifle range with a licensed shooting instructor and they are not to practice any shooting if animals or people are in the pasture next to the rifle range.

A brief discussion was held concerning the sign study for the intersection of road 173 and road 22. Highway Superintendent Krajewski presented Resolution 2024-007 which was read by Clerk Sherman. Resolution 2024-007: Whereas, the Deuel County Highway Superintendent was directed by the Deuel County Board of Commissioners to perform an engineering study at the intersection located in the southwest corner of Section 29, Township 14 North, Range 44 West (intersection of County Road 22 and County Road 173); and whereas, the Deuel County Highway Superintendent has performed the engineering study and based upon said study, (see attached), recommend that a stop sign be installed on County Road 22 for the westbound traffic at the above referenced intersection. Now therefore be it resolved that the Deuel County Board of Commissioners hereby concurs with the attached engineering study and approves the installation of a stop sign based on the Highway Superintendent's recommendation at the intersection located at the southwest corner of Section 29, Township 14 North, Range 44 West (intersection of County Road 22 and County Road 173).

ALSO, WHEREAS, the Deuel County Commissioners have the power to establish a budget to be used by the various Officials/offices to conduct County business. Within this budget, transfers may be adopted to ensure no negative fund balances will occur. THEREFORE, the Deuel County Commissioners authorize County Treasurer Alicia Adams to make a transfer from the County General to the 911 Fund not to exceed the amount of \$7500.00.
