The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Klingman, aye, Timm, aye. A motion by Commissioner Klingman, seconded by Commissioner Timm to approve the July 2nd, 2024, meeting minutes. Timm, aye, Klingman, aye.

Protest #2024-003 ID 313.00, Bosselman Motel Inc., landowner not present. Tract in SE/4SW/4 S & E HWY ROW Sec 31-13-41 2.91 A. The assessor's recommendation was to decrease the total value from \$2,492,680.00 to \$1,820,703.00. A decrease of \$671,977.00.

Protest #2024-004 ID 2193.00, Bosselman, Inc., landowner not present. Lots 1 & 2, Blk 27, Original Town Chappell. The assessor's recommendation was no change in total value.
