Deuel County Commissioner Meeting September 17, 2024

The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Sheriff DeCoste presented the signed interlocal agreement with Creek Valley Schools for a school resource officer. The agreement will automatically be renewed annually unless cancelled by either party with the proper cancellation notice.

Resolution 2024-12, Adoption/Appropriations of the Budget document was approved upon motion by Commissioner Klingman, seconded by Commissioner Reichman; Klingman, aye, Timm, aye, Reichman, aye.

Resolution 2024-13, establishing petty cash funds for the County Attorney in the amount of \$500.00 and the County Court in the amount of \$25.00, was approved upon motion of Commissioner Klingman, seconded by Commissioner Timm; Timm, aye, Klingman, aye, Reichman, aye.

Resolution 2024-14, instructing County Treasurer to transfer funds to the Sheriff Sinking Fund from County General in the amount of \$10,000.00, was approved upon motion of Commission Klingman, seconded by Commissioner Reichman; Timm, aye, Klingman, Reichman, aye.

Resolution 2024-15, instructing County Treasurer to transfer funds to the County General Fund from the County Fair Fund in the amount of \$36,533.23, was approved upon motion of Commissioner Klingman, seconded by Commissioner Timm. Timm, aye, Reichman, aye, Klingman, aye.

Resolution 2024-17, instructing County Treasurer to transfer to the Road & Bridge Fund for the Bonded Debt Service Fund from the County General in the amount of \$284,110.00, was approved upon motion of Commissioner Klingman, seconded by Commissioner Timm; Reichman, aye, Klingman, aye, Timm, aye.
