Deuel County Commissioner Meeting October 15, 2024

The Deuel County Commissioners met on the above date with the following present: Chairperson Jim Reichman, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jon Stellar, County Assessor Michele Bartlett, County Treasurer Alicia Adams, Sheriff's Office Administrator Leslie Snell, Sheriff Scott DeCoste, Deputy Jim McCormick, Kristian Fusilier, Konni Sauder, Brent Fletcher, Todd Hatterman, Larry & LaDean Rutt, Julie Johnson, Loren & Chantal Radke, Tom Dilsaver, Lon Stretesky, Amy Stanley, Paul Kinney, Laurie Armstrong, Greg Nelson, Kristian Wheeler from Nexterra Energy and David Brock from Nexterra Energy and Clerk Tammy Sherman. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, aye, Timm, aye. The minutes of the October 1, 2024, meeting was approved upon motion of Commissioner Klingman, second Commissioner Timm. Reichman, aye, Timm, aye, Klingman, aye.

Public comment. Amy Stanley expressed appreciation for the improvements made on the Day Road.

At 8:35 a.m. a motion was made by Commissioner Reichman, seconded by Commissioner Timm to enter into the Board of Equalization for Resolution 2024-19, setting levies in and for Deuel County. Timm, aye, Klingman, aye, Reichman, aye.

Brent Fletcher, C-Weed Management reviewed the operations for the weed control within the county. For nuisance violations, Fletcher will contact the property owner. If no action is taken to comply with the nuisance order, the County Attorney will contact the property owner. The Commissioners expressed their appreciation for the work done within the county.

Resolution 2024-20, In the matter of Stepping Up Initiative to reduce the number of people with mental illness in jails for Region 1 Behavioral Health Authority, the resolution was read by number and title. A motion by Commissioner Reichman to adopt Resolution 2024-20, seconded by Commissioner Klingman. Timm, aye, Klingman, aye, Reichman, aye.

Resolution 2024-21; authorizing County Treasurer to make a transfer from County General to the County Fair Fund not to exceed the amount of \$11,533.23 due to a calculation error in Resolution 2024-15. A motion by Commissioner Reichman, seconded by Commissioner Klingman, to approve Resolution 2024-21. Timm, aye, Klingman, aye, Reichman, aye.

Resolution 2024-22; authorizing County Treasurer to make a transfer from County General to the 911 Emergency Management Fund not to exceed the amount of \$13,042.64 due to the budget relocation of the 911 Emergency Management expenses to be paid out of the General Fund. \$13,042.64 are the expenses that have been incurred from July 1, 2024, to September 17, 2024. A motion by Commissioner Timm, seconded by Commissioner Klingman to approve Resolution 2024-22. Timm, aye, Reichman, aye, Klingman, aye.

Tourism Director Konni Sauder presented a grant request with the amount of \$15,000 from the City of Chappell for a splash pad to be located near the swimming pool in Chappell. A motion by Commissioner Klingman, seconded by Commissioner Timm to approve the request. Reichman, aye, Klingman, aye, Timm, aye.

Planning and Zoning Administrator Bartlett presented five conditional use permits and two building permits. Public comments were heard from Paul Kinney, Julie Johnson, Laurie Armstrong, Amy Stanley, Lon Stretesky, Greg Nelson, Larry Rutt, LaDean Rutt, Chantal Radke, Kristian Fusilier, and Nexterra Energy representatives. Bartlett explained that Nexterra Energy is requesting to erect four MET Towers in northern Deuel County to collect environmental data. The towers are the size of a cell phone tower and are temporary. They will be taken down at the end of a two-year study. All the conditional use and building permits except building permit 2024-28 were approved by the Planning & Zoning Board. A motion by Commissioner Timm, seconded by Commissioner Reichman to approve conditional use permit 2024-22 Nextra MET Tower. Reichman, aye, Klingman, nay, Timm, aye. A motion by Commissioner Timm, seconded by Commissioner Reichman to approve conditional use permit 2024-23 Nextra MET Tower. Reichman, aye, Klingman, nay, Timm, aye. A motion by Commissioner Timm, seconded by Commissioner Reichman to approve conditional use permit 2024-24 Nextra MET Tower. Klingman, nay, Reichman, aye, Timm, aye. A motion by Commissioner Timm, seconded by Commissioner Reichman to approve conditional use permit 2024-25 Nextra MET Tower. Reichman, aye, Timm, aye, Klingman, nay. A motion by Commissioner Timm, seconded by Commissioner Reichman to approve conditional use permit 2024-27 GWF Properties for a 30,000-gallon propane tank. Reichman, aye, Klingman, aye, Timm, aye. A motion by Commissioner Klingman, seconded by Commissioner Reichman to approve building permit 2024-26 for a 30 x 40 garage. Timm, aye, Klingman, aye, Reichman, aye. A motion by Commissioner Klingman, seconded by Commissioner Timm to deny building permit 2024-28 because it is within the one-mile jurisdiction of Big Spring. Timm, aye, Klingman, aye, Reichman, aye.

Fusilier updated the Board on the operations in the roads department. The department is having issues with a couple of the graders and a truck. The patch work will continue on Wheatland Rd and Rd 165 South of Chappell.

Treasurer Alicia Adams presented information on the ARPA Funds. After a brief discussion, an estimate will be obtained for ADA compliance bathrooms for Big Springs Fire Hall and septic system repairs for the Chappell Shop. The estimates are to be presented at the next meeting on November 5th.

Sheriff DeCoste reported for the Sheriff's office. Sheriff DeCoste presented the September fee report. Total fees collected were \$395.70.
