The Deuel County Tourism report for October was presented for review and filing.

No business for the Board of Equalization.

The Deuel County Fair Board is requesting approval to apply for a grant to improve the well at the fair grounds with the Virginia Smith Charitable Trust. A motion by Commissioner Reichman, seconded by Commissioner Klingman to approve the request to apply for a grant with the Virginia Smith Charitable Trust for improvements to the well. Klingman, aye, Timm, aye, Reichman, aye.

A motion by Commissioner Klingman, seconded by Commissioner Reichman to approve the following building permits per the recommendation of the Deuel County Planning and Zoning Board; 2024-29 cattle shed; 2024-30 removing equipment on a radio tower; 2024-31 renewing an expired permit for a dwelling and improvements in a barn. Highway Superintendent Krajewski updated the Board on the operations in the roads department. A discussion was held on the duties for the assistant highway superintendent. Krajewski will collaborate with Fusilier for the next two years, until Fusilier is eligible to request a class A license. Patch work will continue.

A discussion was held concerning the allocation of the ARPA funds. A motion was made by Commissioner Klingman, seconded by Commissioner Reichman to allocate \$3,107.72 for sewer work at county roads shop number 1. Timm, aye, Klingman, aye, Reichman, aye. Sheriff DeCoste advised that Garden County has a 2021 Ford Explorer patrol vehicle for sale. The Commissioners agreed that it would be to the County's advantage if DeCoste could get it purchased for the Sheriff's Dept.
