Re-organizational Meeting for January 7, 2025

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Jim Reichman, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jon Stellar, County Treasurer Alicia Adams, County Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Sheriff Scott DeCoste, Sheriff Deputy Jim

McCormick, Roads Superintendent Kelly Kopetsky, Assistant Highway Superintendent Kristian Fusilier, Highway Superintendent Tony Krajewski and County Clerk Tammy Sherman. The meeting was called to order at 8:35 a.m.

The first order of business was the election of a chairperson. The County Clerk was instructed to accept a motion for the 2025 Chairperson. It was moved by Commissioner Klingman, second of Commissioner Timm, that Jim Reichman be elected to serve as the 2025 Chairperson of the Board. Reichman, abstain, Timm, aye, Klingman, aye. The motion carried and Jim Reichman will serve as the 2025 Board Chair.

Upon motion of Commissioner Klingman, second of Commissioner Timm, the mileage rate to be reimbursed to Deuel County Employees will be set at \$.70 cents a mile and the meals reimbursement rates be set as: breakfast \$16, lunch \$19, dinner \$28, incidental \$5. *(Per Commissioner Minutes March 5, 2001, the mileage and meals reimbursement rates will be the same as the ones recommended by NE Department of Administrative Services.) Upon motion of Commissioner Klingman, second of Commissioner Reichman, the Chappell Register and the Sidney Sun will be designated as the Official Papers in and for Deuel County, and the Deuel County Website (www.co.deuel.ne.us), when available, shall also be used for notifying the public of upcoming events and the minutes of record in and for Deuel County, Nebraska for the year 2025. Anthony Krajewski will be appointed as Deuel County Highway Supt. for the Calander year 2025, upon motion of Commissioner Klingman, second of Commissioner Reichman. Reichman, aye, Klingman, aye, Timm, aye. Reference was made to the appointment of Kristian Fusilier as Assistant Highway Superintendent as of November 19, 2024.

Motion was made by Commissioner Klingman, second of Commissioner Timm, to approve contracted building and grounds maintenance with Jim Reichman in the amount of \$850 per month. Reichman, abstain, Klingman, aye, Timm, aye.

Motion was made by Commissioner Klingman, second of Commissioner Reichman, to approve contracted janitorial services with Anna Collins with a base rate of \$625 per month. Klingman, aye, Timm, aye, Reichman, aye.

It was moved by Commissioner Klingman, second of Commissioner Reichman, that the following persons be reappointed to the Deuel County Fair Board for 2025 Jeff Ortgies, Clint Koenen, Amanda Mathis, Amanda Alexander. Current members Zada Sauers, Ben Hansen, and Teri Doty 2026; Paul Payton, Cori Koehler, and Kegan Brott 2027; Haley Magee and Leslie Snell 2028; filling the 12-member board. Klingman, aye, Reichman, aye, Timm, aye.

Exceptions may include law enforcement, security, military, and employees engaged in other essential functions, such as 24-hour facilities. *If such a holiday falls on a Saturday, the preceding Friday will be a holiday, and such day will be declared a holiday. If such holiday falls on a Sunday, the following Monday will be a holiday as designated in the Deuel County Personnel Policy.

The Elected Officials will receive the following salaried amounts for the year 2025 as per Resolution 2022-2 approve January 4, 2022, per Nebraska statute. Resolution 2025-2: Additional compensation for the Deuel County Sheriff for serving as the 911 Coordinator and additional compensation for the Deuel County Assessor for serving as the Planning & Zoning Administrator was read by Commissioner Reichman, which was presented for regulatory and clarification purposes. RESOLUTION #2025-2: WHEREAS it is necessary for the Deuel County Board of Commissioners to set salaries (Neb. Rev. Stat. 23-1114 reissue 2012) for the elected County Officials of Deuel County as declared in Resolution 2022-2 for the years 2023 through 2026. THEREFORE, BE IT RESOLVED, by the Deuel County Board of Commissioners the following addendum be added to RESOLUTION 2022-2: the annual salary for the Deuel County Sheriff is set in Resolution 2022-2 for the years 2023 through 2026. In addition to the County Sheriff's salary, the County Sheriff will receive an additional \$9,600 per year for the service of 911 coordinator. The annual salary for the Deuel County Assessor is set in Resolution 2022-2 for the years 2023 through 2026. In addition to the County Assessor's salary, the County Assessor will receive an additional \$14,400 for 2025 for serving as the Planning & Zoning administrator. BE IT FUTHER RESOLVED, that in addition to the salaries as set forth in Resolution 2022-2 barring any mandates from Federal or State governments, which would change contributions of employer and employee for health coverage, that in addition to the above stated salary, each of the elected officials shall receive whatever health plan that is in place for each of the employees and adopted by the Board of Commissioners, and that such alteration in deductibles or change in the portion paid by the individual shall not constitute an increase or decrease in the herein adopted salary. Motion by Commissioner Reichman, seconded by Commissioner Klingman to approve Resolution 2025-2 as presented. Reichman, aye, Klingman, aye, Timm, aye.

Upon motion of Commissioner Klingman, second of Commissioner Reichman, Cameron Christensen is re-appointed to the County Planning Committee to serve a 3-year term, to meet as required. All building permits will be approved by the committee and advanced to the County Board for formal approval. The Deuel County Tourism report for December was presented for review and filing.
