No business for the Board of Equalization.

Jeff Ortgies with Frenchman Valley Coop presented the fuel usage report for the fuel purchased from FVC for 2024. A motion was made by Commissioner Klingman and seconded by Commission Reichman to have Roads Superintendent Kopetsky sign the fuel agreement for 2025 with a contract price of \$3.09 for dyed fuel and the same contacted gallons as 2024. Reichman, aye, Klingman, aye, Timm, aye.

A motion by Commissioner Reichman, seconded by Commissioner Klingman to appoint Jen Foster to the vacant position on the Deuel County Extension Board for a 3-year term. Timm, aye, Klingman, aye, Reichman, aye.

County Attorney Jon Stellar was unable to attend the meeting. Pathology/Autopsy Service for Deuel County is tabled until the next meeting.

Appointment of the Non-Commissioner Panhandle Public Health District alternate member for 2025 as the "spirited citizen" was tabled until a representative can be confirmed.

Deuel County Treasurer Alicia Adams presented the Six-Month Report. It was reviewed and accepted for filing.

Eakes Office Solutions prepared a proposal to combine the fax services and telephone services into one account/billing. The offices will all keep the same phone numbers and fax numbers. Eakes can provide the services for \$371.60 less per month than what the county is currently being charged. The service does not require a contract and can be cancelled at any time. A motion by Commissioner Klingman, seconded by Commissioner Reichman, to move forward with the transition to Eakes Office Solutions for the fax and telephone services. Planning & Zoning; no business.

Hwy. Superintendent Krajewski and Roads Superintendent Kopetsky reported for the Roads Dept. The road rights-of-way will continue to be cleared. Repairs continue on the equipment.

Treasurer Adams reported for the ARPA Funds Committee. Still waiting to get all the final bills. The annual report will be submitted in April.

Sheriff DeCoste presented Sheriff's report for December \$5,378.10. He also reported for the Sheriff's office. The Dept. was able to purchase the 2021 Ford Explorer from Garden County.

Janet Lane was sworn in as Deuel County Deputy Treasurer.
