No business for the Board of Equalization.

Planning & Zoning; no permits or applications for review. Zoning Administrator Michele Bartlett addressed the board for a review of the expectations of the Planning & Zoning Committee regarding the zoning regulations for wind towers and solar panels. Planning & Zoning Committee member Cameron Christensen advised that it is the goal of the Planning & Zoning Board to do what is right for the county. The process for reviewing the regulations for the wind towers and solar panels has been tedious. They have been looking at the zoning regulations in all ninety-three counties, trying to determine a workable solution for Deuel County. Christensen asked about the expectations of the Commissioners of the Planning & Zoning Board. Lori Armstrong, Toby Spies, Paul Kinney, and Britten Rageth spoke in support of and appreciation of the work the Planning & Zoning Committee has been doing. Commissioner Klingman asked about just reviewing the regulations for the panhandle counties. Bartlett advised that there are small counties in eastern Nebraska that are dealing with this comparable situation. It has been helpful reviewing these regulations in determining what may be best for Deuel County. Timm asked for a review of what has been done to date. Bartlett will get the information for the Commissioners. Reichman asked if it would be possible for the Planning & Zoning Board to meet monthly during the winter months, only while reviewing these regulations. Bartlett will ask the other committee members. Reichman, Timm and Klingman all expressed their appreciation to the members of the Planning & Zoning Committee for their dedication to the county and this project.

Assessor Bartlett presented the contract with Cardinal Assessment Group for the term 8-1-2025 through 7-30-2026. Same terms as last year. A motion was made by Commissioner Klingman, seconded by Commissioner Timm to approve the contract as presented. Reichman, aye, Timm, aye, Klingman, aye.

A motion was made by Commissioner Klingman, seconded by Commissioner Reichman to table the Eagle View contract amendment until September 16, 2025. Timm, aye, Klingman, aye, Reichman, aye.

Assistant Hwy Superintendent Fusilier and Roads Superintendent Kopetsky updated the board on operations in the department. They have received three applications for the open position. A bid from the State was received in the amount of \$42,000 for a new pickup. The mowing is about done.

Sheriff's Dept. Admin. Assistant Leslie Snell updated the Commissioners on the happenings within the Sheriff's department. Sheriff DeCoste had to attend another meeting.

A safety committee meeting was held.

The Clerk's report for August was presented for review and filing. Fees in the amount of \$1,241.45 were collected.

There being no further business, the board adjourned at 10:04 a.m. The next regular meeting of the Board of Commissioners will be Tuesday, September 16, 2025.
