Ron Leal, Region One Emergency Management Director, presented the updated emergency operations plan for Deuel County and the Basic Emergency Operations Plans.

Public comment. Lonnie Dallegge addressed the Board regarding authority of the County Assessor to change property classifications for tax purposes. The matter will be researched, and Mr. Dallegge will be contacted.

The Deuel County Court monthly report for September was presented for review and filing. The total fees for the month are \$117,221.71. The Deuel County Clerk monthly report for September was presented for review and filing. The fee totals \$673.99. The Deuel County Tourism report for July through September was presented for review and filing.

A motion by Commissioner Klingman seconded by Commissioner Reichman to enter the Board of Equalization at 8:36 a.m. Reichman aye, Klingman aye, Timm aye.

Randy Yoder expressed his concern regarding the prairie dog expansion on to his property. Stellar will do some research on this matter and send out a letter.

Planning and zoning. No permits or applications for review.

Assessor Bartlett present the Assessor's office updated three-year plan to correct the budget for 2025 to read \$256,685. A motion by Commissioner Timm, seconded by Commissioner Reichman to approve the Assessor's amended three-year plan as presented. Reichman, aye, Timm, aye, Klingman, aye. Bartlett also presented a change to the GIS contract to add

zoning and the floodplain layers. Bartlett explained the importance of these layers is because if anyone builds in the flood plain without the proper permit, they could have to take the building down and rebuild it according to flood plain regulations. This addition will help residents determine if they are in a flood zone. A motion by Commissioner Reichman, seconded by Commissioner Klingman to approve the GIS contract change as presented. Timm, aye, Reichman, aye, Klingman, aye.

Resolution 2025-0017 was presented; With designation as a Green Light for Veterans County, DEUEL COUNTY hereby declares November 4-11, 2025, as a time to salute and honor the service and sacrifices of those transitioning from active service; and that in observance of Operation Green Light, DEUEL COUNTY will light up the courthouse with green lights from November 4th to November 11th, 2025; and that DEUEL COUNTY encourages its citizens in patriotic tradition to recognize the importance of honoring all those who made immeasurable sacrifices to preserve freedom by displaying green lights in a window of their place of business or residence from November 4-11, 2025. Upon a motion from Commissioner Reichman, seconded by Commissioner Timm Resolution 2025-0017 was approved. Reichman, aye, Timm, aye, Klingman, aye.

Veteran Service Officer Patricia Nelson reported for her office. She had been working with the 4-H office for the presentation of the quilt of valor. She has been attending training, collaborating with veterans and the local veteran programs. The VSO office also shared a table at the fair with the VFW promoting veteran services. The Commissioners expressed the importance and appreciation of the Veterans Service Office.

Highway Superintendent Krajewski, Assistant Hwy Superintendent Fusilier and Roads Superintendent Kopetsky updated the Board on the operations in the roads department. A brief discussion was held on a new road surfacing product available for the hardening of dirt roads. The fee is \$9,000 a mile, does not include any of the prep work and requires three days without any traffic.

A brief discussion was held concerning the repairs needed for the 2021 Dodge Durango for the Sheriff's Department. Snell will research the cost of replacing this vehicle and present the information at the next meeting.

Sheriff's office administrator Leslie Snell, reported for the Sheriff's office. The fee report for September was presented for review and filing. The fees collected for September were \$592.00.

At 10:02 a.m. a motion was made by Commissioner Reichman, seconded by Commissioner Timm to enter executive session with the following present, Reichman, Timm, Klingman, and Sherman. Klingman, aye, Timm, aye, Reichman, aye. At 10:15 a.m. a motion was made by Commissioner Klingman seconded by Commissioner Reichman to reconvene the regular meeting.
