Planning & Zoning; no permits or applications for review. Planning & Zoning Administrator Bartlett stated that she had received calls for permits on AI data centers and bit coin mining. The current zoning regulations do not address these types of permits; she will do research into this matter.

Hwy Superintendent Krajewski, Assistant Hwy Superintendent Fusilier and Roads Superintendent Kopetsky updated the board on operations in the department. The training of the new employee is going well. The mower is out of the repair shop and being used.

A brief discussion was held concerning a survey request received from NACO for participation in a work release for state prisoners. The county does not have a jail to house the participants therefore the county will not participate in the program.

Sheriff DeCoste presented options for the repair of the 2021 Dodge Durango. A motion was made by Commissioner Reichman, seconded by Commissioner Klingman to have the vehicle repaired by Ron's Chappell Auto for \$12, 117.50 to include a three-year warranty. Timm, aye, Reichman, aye, Klingman, aye.

Sheriff DeCoste updated the Commissioners on the happenings within the Sheriff's department. The report for September was presented for review and filing. Fees collected for the month of September \$454.30.
