No business for the Board of Equalization.

Planning & Zoning; no permits or applications for review. A motion was made by Commissioner Klingman, seconded by Commissioner Reichman to approve Marvin Planning Consultants, Inc. to do the Deuel County Comprehensive Plan that is up for review in 2026. Reichman, aye, Klingman, aye, Timm, aye.

The memorandum of understanding with Cheyenne, Kimball, and Deuel Counties to form a coalition for the purpose of applying for the FY 2027 Community-Based Juvenile Services Aid was presented. No changes from last year. A motion was made by Commissioner Klingman, seconded by Commissioner Reichman, to approve the memorandum of understanding as presented. Timm, aye, Reichman, aye, Klingman, aye.

Deuel County Treasurer Adams presented the annual sales tax report for the Deuel County Fair.

A brief discussion was held concerning the pop cooler for the 4-H building at the fairgrounds. A bid from Pepsi Cola of Western Nebraska was received in the amount of \$2,648.64 (delivered, installed and service available). A motion was made by Commissioner Timm, seconded by Commissioner Klingman to approve the purchase of the cooler for the 4-H building. Reichman, aye, Timm, aye, Klingman, aye.

Hwy Superintendent Krajewski, Assistant Hwy Superintendent Fusilier and Roads Superintendent Kopetsky updated the board on operations in the department. Job evaluations have been completed on the new hires. A wage increase of fifty cents per hour will be applied to the new hires' hourly pay rate. The new 2026 pickup has been ordered, per the state bid requirements for the Chappell shop. The department is having trouble with right-of-way violations. Co. Attorney Stellar will work with the department for a solution.

Sheriff's Office Administrator Snell updated the Commissioners on the happenings within the Sheriff's department. The report for November was presented for review and filing. Fees collected for the month November \$662.20.

The quarterly safety meeting was held.

Clerk Sherman reviewed updated procedures for submitting claims and credit card usage.

Discussion was held regarding the 2027-2030 NACO elected officials' salary study. Per Neb. Rev. Statute 23-1114 salaries for elected officials must be sent by resolution for a four-year period prior to January 15th of the year in which a general election is to be held for the respective offices: County Commissioners, County Treasurer, County Assessor, County Attorney, County Sheriff, and County Clerk. The NACO recommends a wage increase between 19% and 27%. NACO explained the cost-of-living rate has been higher than what counties have been factoring into wages. A motion was made by Commissioner Timm, seconded by Commissioner Klingman to schedule a special meeting December 30, 2025, at 8:30 a.m. for the purpose of setting the salaries for the elected officials and performance reviews for the appointed positions. Reichman, aye, Klingman, aye, Timm, aye.

At 10:04 a.m. a motion was made by Commissioner Klingman, seconded by Commissioner Reichman, to enter executive
session for a personnel matter with Klingman, Reichman, Timm, Stellar and Sherman present. Reichman, aye, Klingman,
aye, Timm, aye. A motion was made by Commissioner Klingman, seconded by Commissioner Reichman to reconvene
regular session @ 10:36 a.m. Klingman, aye, Timm, aye, Reichman, aye.
