

Deuel County Commissioner Meeting
January 6, 2026

The Deuel County Commissioners met on the above date with the following present: Chairperson Jim Reichman, Commissioner William Klingman, County Treasurer Alicia Adams, County Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Sheriff Scott DeCoste, Sheriff Deputy Jim McCormick, Roads Superintendent Kelly Kopetsky, Assistant Hwy Superintendent Kristian Fusilier, Hwy Superintendent Anthony Krajewski, and County Clerk Tammy Sherman. A motion was made by Commissioner Klingman, seconded by Commissioner Reichman for an excused absence for Commissioner Timm. Reichman, aye, Klingman, aye, Timm, absent. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. A motion was made by Commissioner Reichman, seconded by Commissioner Klingman to approve the consent agenda; approve agenda for January 6, 2026, minutes for December 16, 2025, meeting and minutes for the December 30, 2025, meeting. Timm, absent, Klingman, aye, Reichman, aye.

Public comment, none.

Re-organizational Meeting for January 6, 2026

The Deuel County Commissioners met on the above date for the business of re-organizing for 2026 with the following present: Chairperson Jim Reichman, Commissioner William Klingman, County Treasurer Alicia Adams, County Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Sheriff Scott DeCoste, Sheriff Deputy Jim McCormick, Roads Superintendent Kelly Kopetsky, Assistant Hwy Superintendent Kristian Fusilier, Hwy Superintendent Anthony Krajewski and County Clerk Tammy Sherman. The meeting was called to order at 8:35 a.m.

The first order of business was the election of a chairperson. The County Clerk was instructed to accept a motion for the 2026 Chairperson. It was moved by Commissioner Klingman, second of Commissioner Reichman, that Jim Reichman be elected to serve as the 2026 Chairperson of the Board. Timm, absent, Klingman, aye, Reichman, aye.

Upon motion of Commissioner Reichman, second of Commissioner Klingman, the mileage rate to be reimbursed to Deuel County Employees will be set at \$.725 cents a mile. *(Per Commissioner Minutes March 5, 2001, the rate will be the same as the one recommended by NE Department of Administrative Services; the rate has been set by DAS to .725 cents, effective 01/01/26.) Reichman, aye, Klingman, aye, Timm, absent.

Motion by Commissioner Klingman, seconded by Commissioner Reichman to set the 2026 per diem rate for Nebraska reimbursement rates for meals and incidentals, per US General Services Administration at \$16 for breakfast, \$19 for lunch, \$28 for dinner and \$5 for incidentals. Reichman, aye, Timm, absent, Klingman, aye.

Upon motion of Commissioner Klingman, second of Commissioner Reichman, that the Chappell Register and the Sidney Sun be designated as the Official Papers in and for Deuel County, and the Deuel County website www.deuelcountyne.gov, shall also be used for notifying the public of upcoming events and the minutes of record in and for Deuel County, Nebraska for the year 2026. Timm, absent, Reichman, aye, Klingman, aye.

Anthony Krajewski will be appointed as Deuel County Highway Supt. for calendar year 2026, upon motion of Commissioner Klingman, second of Commissioner Reichman. Reichman, aye, Klingman, aye, Timm, absent.

The motion was made by Commissioner Klingman, second of Commissioner Reichman, to approve contracted building and grounds maintenance with Jim Reichman in the amount of \$850.00 per month. Klingman, aye, Timm, absent, Reichman, aye.

Motion was made by Commissioner Reichman, second of Commissioner Klingman, to approve contracted janitorial services with Anna Collins with a base rate of \$625.00 per month. Klingman, aye, Timm, absent, Reichman, aye.

It was moved by Commissioner Klingman, second of Commissioner Reichman, that the following persons be reappointed to the Deuel County Fair Board for 2026 Zada Sauers, Ben Hansen, and Teri Doty. All persons are Deuel County residents and will be appointed members of the board for three years. Other members are Paul Payton, Cori Koehler, and Kegan Brott for 2027, Leslie Snell and Haley McGee for 2028; Jeff Ortgies and Clint Koenen, Amanda Mathis, Amanda Alexander 2029, filling the 12-member board. Klingman, aye, Reichman, aye, Timm, absent.

Upon motion of Commissioner Klingman, second of Commissioner Reichman, the Deuel County Lodging tax committee members Shauna Mashek of Chappell and Kathy Peterson of Big Springs will be reappointed for 2026. Other members of the board are Randy Shaw of Big Springs, Rod Hanson of Chappell and Cindy Williams of Chappell whose terms expire in 2028. Reichman, aye, Timm, absent, Klingman, aye.

Upon motion of Commissioner Klingman, second of Commissioner Reichman, the following holidays were approved. Klingman, aye, Reichman, aye, Timm, absent.

*And all days declared by law or proclamation of the Governor to be a holiday According to Neb. Rev. Stat. §84-1001 (3), "For purposes of this Section, paid holidays shall include all of the days enumerated in Section 25-2221 and all days declared by law or proclamation of the President or Governor to be holidays." Exceptions may include law enforcement, security, military, and employees engaged in other essential functions, such as 24-hour facilities. *If such holiday falls on a Saturday, the preceding Friday will be a holiday, and such day will be declared a holiday. If such holiday falls on a Sunday, the following Monday will be a holiday as designated in the Deuel County Personnel Policy.

A motion by Commissioner Reichman, seconded by Commissioner Klingman to approve Resolution 2026-2; Additional compensation for the Deuel County Sheriff for serving as the 911 Coordinator (\$9,600 annually) and additional compensation for the Deuel County Assessor for serving as the Planning & Zoning Administrator (\$14,400 annually). Reichman, aye, Klingman aye, Timm, absent.

A motion by Commissioner Klingman, second of Commissioner Reichman, Justin Julius, to be reappointed to the County Planning Committee to serve a 3-year term and to meet as required. All building permits will be approved by the committee and advanced to the County Board for formal approval. Other members of the planning committee are Larry McCroden, and Gary Freeman for 2027, Jason Cheleen for 2028 and Cameron Christensen for 2029. Reichman, aye, Klingman, aye, Timm, absent.

The Deuel County Tourism report for December was also presented for review and filing.

A motion by Commissioner Klingman, seconded by Commissioner Reichman to approve the signing of the contract with Marvin Planning Consultants for the update of the Deuel County Comprehensive Plan & Zoning Regulations. Reichman, aye, Timm, absent, Klingman, aye.

A motion by Commissioner Klingman, seconded by Commissioner Reichman to approve the request by the Deuel County Fair Board to apply for grants with the Thomas Buckley Trust and the Virginia Smith Trust for 2026 fair expenses. Timm, absent, Reichman, aye, Klingman, aye.

Krajewski, Fusilier and Kopetsky reported on the operations of the highway department. The mowing is almost complete.

Sheriff DeCoste reported for his office.

The following was read in open session; DEUEL COUNTY RESOLUTION 2026-3: WHEREAS, pursuant to Neb. Rev. Stat. § 23-1114 Reissue 2012, the salaries of the County elected officials are to be established by the County Board prior to January 15th of the year in which a general election is to be held for the respective offices; and, WHEREAS a general election will be held in 2026 for the offices of Assessor, Attorney, Clerk, Commissioner, Sheriff, Surveyor, and Treasurer; and, NOW, THEREFORE, BE IT RESOLVED by the County Board of Deuel County, Nebraska, the annual salary for the office of County Clerk, County Assessor and County Treasurer for the next elected term, shall be established at \$64,000 for calendar year 2027. That for each year thereafter, a \$2,000.00 cost-of-living increase shall be added to the previous year's salary so the total amount paid for calendar year 2028 shall be \$66,000.00, for calendar year 2029 shall be \$68,000.00, and for calendar year 2030 shall be \$70,000.00. Further, in addition to the above salary, the County Clerk, County Treasurer and County Assessor shall receive during his or her term of office the health insurance coverage offered to all County employees at County expense. BE IT FURTHER RESOLVED by the County Board of Deuel County, Nebraska, the annual salary for the office of County Commissioner for the next elected term shall be established at \$24,160.00 for calendar year 2027. That for each year thereafter, a \$1,000.00 cost-of-living increase shall be added to the previous year's salary so the total amount paid for calendar year 2028 shall be \$25,160.00 for calendar year 2029 shall be \$26,160.00, and for calendar year 2030 shall be \$27,160.00. Further, in addition to the above salary, the County Commissioner shall receive during his or her term of office the health insurance coverage offered to all County employees at County expense. The Chairperson will also receive an additional \$500.00 annually during the year serving as chairperson. BE IT FURTHER RESOLVED by the County Board of Deuel County, Nebraska, the annual salary for the office of County Sheriff for the next elected term shall be established at \$83,200.00 for calendar year 2027. That for each year thereafter, a \$2,000.00 cost-of-living increase shall be added to the previous year's salary so the total amount paid for calendar year 2028 shall be \$85,200.00, for calendar year 2029 shall be \$87,200.00, and for calendar year 2030 shall be \$89,200.00. Further, in addition to the above salary, the County Sheriff shall receive during his or her term of office the health insurance coverage offered to all County employees at County expense. BE IT FURTHER RESOLVED by the County Board of Deuel County, Nebraska, the annual salary for the office of County Attorney for the next elected term shall be established at \$75,000.00 for calendar year 2027. That for each year thereafter, a \$2,000.00 cost-of-living increase shall be added to the previous year's salary so the total amount paid for calendar year 2028 shall be \$77,000.00, for calendar year 2029 shall be \$79,000.00, and for calendar year 2030 shall be \$81,000.00. Further, in addition to the above salary, the County Attorney shall receive during his or her term of office the health insurance coverage offered to all County employees at County expense. A motion was made by Commissioner Klingman, seconded by Commissioner Reichman to approve Resolution 2026-3 as read. Reichman, aye, Timm, absent, Klingman, aye.
