Deuel County Commissioner Meeting

April 21, 2015

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner Bill Klingman, Commissioner Jerry Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed with a moment of silence for reflection. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye. A motion was made by Commissioner Fischer, to approve the minutes of the April 7, 2015 commissioner meeting, second of Commissioner Klingman. Radke, aye, Fischer, aye, Klingman, aye.

County Highway Supt. Kara Essman and road foreman Matt Bartels met with the board to discuss the operations of the highway dept. Upon motion of Commissioner Fischer, second of Commissioner Klingman to approve a gravel agreement with Nebraska and Western Company in the amount of 50 cents per yard. Radke, aye, Fischer, aye, Klingman, aye. Discussion was held regarding the current organization of the road and bridge employees. Historically, there have been shop foremen placed in each shop. The board is actively considering the implementation of re-organizing the hierarchy and appointing one foreman to oversee all shops. Decisions will be made prior to the budget year, preferably during the wage discussion in June.

Recommendations from the Zoning Board were reviewed. Discussion was held regarding Resolution 2015-4, adoption of amended zoning regulations to include wind farm discontinuation and decommissioning procedures, including a 1% per tower decommissioning fee to be placed in an escrow account with a local bank located in Deuel County. Upon motion of Commissioner Klingman, second of Commissioner Fischer, Resolution 2015-4 was approved. Radke, aye, Klingman, aye, Fischer, aye.

Custodian Keil Velasco presented a maintenance report. The board encouraged him to obtain estimates for the repair of the windows of the annex, the door and the concrete in the front of the building.

Upon motion of Fischer, second of Commissioner Radke, Resolution 2015-5, a special designated permit for a beer garden during the Deuel County Fair on August 6th, 7th and 8th; was approved. Fischer aye, Klingman, aye, Radke, aye.

Upon motion of Commissioner Fischer, second of Commissioner Klingman, Resolution 2015-6 the Annual Handi-bus Resolution was approved. Radke, aye, Fischer, aye, Klingman, aye.

Discussion was held pertaining to the Sale barn lease with Sandpoint Cattle Company, L.L.C. Clarification was made pertaining to the lease agreement. Arrearages in the amount of \$3,250.00, will be set aside due to the painting and other repairs made. Beginning in January 2015, the annual lease agreement will become due in the amount of \$500.00, regardless of the improvements, repairs or maintenance made to the property.

Upon motion of Commissioner Radke, second of Commissioner Klingman, Resolution 2015-7, a special designated permit for a wedding reception to be held at the Deuel County Fairgrounds on June 27, 2015, was approved. Fischer, aye, Radke, aye, Klingman, aye.

Sheriff Adam Hayward presented a report of Distress Warrants in the amount of \$996.41. This report included two warrants, both of which were collected and interest collected,(not included in the warrant amount) in the amount of \$23.10. This report was reviewed and accepted for filing.

Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Radke, aye, Fischer, aye, Klingman, aye. A motion was made by Commissioner Radke, to approve the minutes of the May 5, 2015 commissioner meeting, second of Commissioner Klingman. Fischer, aye, Radke, aye, Klingman, aye.

County Clerk/Clerk of the District Court Polly Olson presented a report of fees collected by her office in the amount of \$2,111.47 for the month of April, 2015. This report was reviewed and accepted for filing.

David Goebel, representing Ameresco, presented a report of findings after a preliminary audit of the Deuel County Courthouse. The report defined projects that would increase the energy efficiency of the county, thus saving money. The audits from 2012, 2013 and 2014 were provided to allow Mr. Goebel to obtain financial information.

A resignation from Custodian Keil Velasco was accepted upon motion of Commissioner Fischer, second of Commissioner Klingman. Radke, aye, Fischer, aye, Klingman, aye. Discussion was held pertaining to filling the position versus contracting out janitorial services and hiring maintenance as needed. A motion was made by Commissioner Klingman, second of Commissioner Fischer to install a light system to display the flag properly. Radke, aye, Klingman, aye, Fischer, aye. Commissioner Fischer will contact Carol Laugen who currently works part-time

Upon motion of Commissioner Fischer, second of Commissioner Klingman, Resolution 2015-9 the Blue Cross Blue Shield Sub-group application was approved with no changes from plan approved last year. The rates have decreased 3%, single coverage for each full time employee working 30 hours per week. \$728.56 per month, Employee/spouse or Employee/children \$1,462.54, Employee/family \$1,673.28. If the employee chooses to cover spouse/children, it will be at the employees' expense for the additional coverage. The dental program will be offered at the employee's expense also with a decrease. Premier Option 3 for active employees: Per month; Employee only \$22.44, Employee/spouse or Employee/children \$72.90, and Employee/family \$83.42. Deuel County will continue to participate with the PPO Medical Plan, \$1,500.00 deductible, with a \$1,000.00 buy-back program administered with Mid-American Benefits. Radke, aye, Fischer, aye, Klingman, aye. Sheriff Deputies receive full coverage of health insurance at the county's expense, due to the inter-local agreements for law enforcement with the City of Chappell and the Village of Big Springs.

Terry Duffield was present to discuss the current animal control contract and request an increase in the current monthly fee in the amount of \$225.00 to \$500.00 and reimbursement of mileage. Discussion was held pertaining to the costs associated with caring for the abandoned and abused animals. Mileage expenses, Euthanasia and vet costs are concerns that are hard to budget for.

Assessor Jean Timm met with the board to discuss the procedures used during the Board of Equalization Protest Hearings. There was no action for the Board of Equalization.

Highway Supt. Kara Essman, road foremen Matt Bartels, Gregg McGreer and Mark Heidemann met with the board to discuss the operations of the highway department.

Sheriff Adam Hayward presented a report of fees collected in his office for the month of April in the amount of \$205.61. This report was reviewed and accepted for filing.
